We manufacture and sell GPSR-compliant products. Irrespective of GPSR, our products have always been subject to the strictest and highest quality requirements. Technical documentation and internal risk analyses are created for product quality, functionality and safety. Solutions are developed for existing products that are not GPSR-compliant so that they are only temporarily unavailable.

It is possible to contact us directly. Company name and business address as well as either e-mail address, URL or QR codes are printed on the packaging.

Warnings in the relevant languages and warning pictograms are provided on the packaging or on a sticker or multilayer sticker to highlight possible risks due to improper use.

If the product falls under the Machinery Directive, the Product Safety Directive or other CE-relevant regulations, the CE marking is visibly affixed to the packaging and/or the product.

For traceability purposes, a date code is affixed to the product so that the part can be identified/traced in the event of possible recalls or quality problems.

If type approval by the German Federal Motor Transport Authority (KBA) is required for the product, the type approval number is printed on the product itself.

In case of a safety-relevant product, installation instructions are supplied or can be accessed via a QR code.
